ABSTRACT

The Dunn Papers consists of receipts dated between 1817 and 1878 for members of the Dunn family. The receipts primarily document personal debts and purchase of goods and services. One receipt is for the “the negro girl,” who was presumably a slave, upon the death of the father of Mary (McDonald) Dunn.
